At the outset, the convener welcomed the members and addressed them about the prevention of the practice of ragging in our educational institution. The following strategies were planned & decided to be implemented in our institution:

1. Anti-ragging slogan "Ragging is strictly prohibited" & anti-ragging poster will be prepared in large numbers and displayed on the walls, notice boards & corridors of the college, classrooms, library, common rooms, auditorium, hostels etc. to warn the senior students.
2. A warning note be displayed on the walls & notice boards of our institution specifically mentioning about the strict enforcement of legal & penal provisions to prevent the practice of ragging as per the Hon'ble supreme court.
3. A general body meeting with all the senior students (both UG & PG) will be held shortly in the college auditorium to warn the students against menace of ragging.
4. An undertaking be issued to the parents of each senior student with a special mention that their ward should not indulge in any kind of ragging & also to behave more responsibly & be supportive in their dealing with juniors.


5. An undertaking will be taken from every senior student as per the provisions of anti-ragging verdict by the Hon'ble Supreme Court of India where it will be clearly and specifically mentioned that if she is found to be indulged in any act of ragging, serious disciplinary action will be taken against her without any mercy.
6. Students will be asked to fill in the online anti ragging undertaking form available at UGC Website. They will also be asked to fill undertaking at college level and an affidavit by parents that their wards will not indulge in ragging of new comers.
7. Frequent visits will be made by the committee members at different venues of college campus i.e. classrooms, corridors, porch, garden, hostel, library, canteen etc. Further sub-committees were formulated to have close vigilance regularly of the specific areas mentioned against their names and report to convenor anti ragging committee.

8. Two-three responsible senior students be selected, who will interact with juniors and inform confidentially about ragging cases to the Dean / committee members.
9. A meeting with juniors be held in the college to address this serious issue of ragging. They will also be suggested to inform unhesitantly to the Dean / committee members, if they are being ragged by their seniors.
10. All the students of the College of Community and Applied Sciences be instructed to read the Anti-ragging instructions, mentioned in the information bulletin of the college.
11. It was proposed by the members that request to be made for flying squad of police officers in day time and nights in the college as well as hostel for few days in the beginning, so that menace of ragging can be prevented in our institution.
12. All the members of Anti-ragging committee, as well as other staff members of the college will be requested to vigil the menace of ragging in & out of the educational institution specially in the beginning.

Meeting ended with vote of thanks.


